AP-NORC Center for Public Affairs Research Poll - Balancing Act: The Public's Take on Civil Liberties and Security, A Trend Study: Methodology

The **AP-NORC Center for Public Affairs Research Poll** on civil liberties was conducted from August 12-29, 2013, by NORC at the University of Chicago. AP and NORC staff collaborated on all aspects of the study. Telephone interviews were conducted with 1,008 adults age 18 or older by professional interviewers, who were carefully trained on the specific survey for this study.

Interviews were conducted with 599 respondents on landlines and 409 respondents on cellular telephones, and the sample included the contiguous 48 states, Alaska and Hawaii. Cellular telephone respondents were offered a small monetary incentive for participating as compensation for telephone usage charges. Interviews were conducted in both English and Spanish, depending on the respondent preference.

The combined landline and cell phone data were weighted to account for probabilities of selection, as well as age, sex, education and race, using targets from 2011 American Community Survey. In addition to these factors, the weighting takes into account the patterns of telephone status and usage from the July-December 2012 National Health Interview Survey (NHIS).

The final response rate was 20% percent, based on the widely accepted Council of American Survey Research Organizations (CASRO) method. Under this method, our response rate is calculated as the product of the resolution rate (72 percent), the screener rate (71 percent), and the interview completion rate (40 percent). The overall margin of error was +/- 4.0 percentage points.
